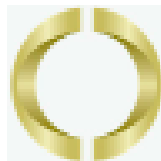

## Education

The Foundation worked closely this past year with the National Equipment Finance Association (NEFA) to present four Institutes for Leasing Professionals (ILP) located throughout the country. The first was hosted by ECS Financial Services in the Chicago area; the second hosted by Financial Pacific Leasing in the Seattle area; the third was hosted by Banc of California in the Southern California area and lastly, FSG Capital helped facilitate a Maryland ILP. The Foundation is also excited to announce that next year a preparatory course geared specifically for the CLP Exam will be offered! Entitled "Academy for Lease & Finance Professionals" (ALFP), this two-day course will cover all three of the mandatory sections of the exam in-depth and help prepare the CLP candidate to be successful in obtaining the designation. The first ALFP is tentatively scheduled to be held in the Southern California area at the end of the first quarter of 2015.

## CLP Associate Designation

In April 2014, the Foundation announced the creation of the CLP Associate Designation. This designation was created in an effort to attract motivated young leasing professionals in our industry to strive for CLP Certification.

While continuing to maintain the current high levels of competency, standards of professionalism and conduct required for full CLP designation, the CLP Associate designation is for the individual with 24-months in the industry who is motivated to participate in the education needed, and sit for the exam prior, to reaching the 3-year threshold. First American Equipment Finance employs the first CLP Associate - Nick Borkowski.
